MEMORANDUM OF UNDERSTANDING FOR THE SUSTAINABLE DEVELOPMENT IN ACTIVITIES ' of ORIENTEERING

The Italian Orienteering Federation (**F.I.S.O.**) and the **PEFC Italy** Association (*Programme for the Endorsement of Forest Certification schemes*) agree to enter into this Memorandum of Understanding for the development of the activities of the Federation and its federal Centres for sustainability , for the use of materials and PEFC certified to support a series of initiatives aimed at the promotion of educational and cultural activities for the sustainable management of local forests.

Given that the FISO and PEFC Italy recognize :

- The importance of education and training of sport carried out in natural environments and in particular in those forests: the sport orientation does not require the construction of any permanent structure and therefore has a great potential sustainability . Practitioners are inserted into the natural environment , are encouraged to get to know , appreciate and respect;
- The high conservation value of the areas where orienteering is practiced and , in times of major events , the relatively high number of participants and spectators requires your full attention to the design and management of events , so that they can become moments of information , knowledge and experience of environmental awareness and sustainability;
- Being the natural forest environment for excellence that today in Italy is a good extension in mountainous areas with an increasing degree of naturalness : the biomass level is rising, its renewal shall be made by the natural , the proportion of deciduous and minor species is growing;
- The importance of free access to the forest for recreation and physical activities and sports that allow you to make direct contact with a rich natural environment and of high value and to experience a natural fit for those who live in highly artificial . This facilitates the appreciation of the forest and therefore society's willingness to invest for its sustainable use;
- The sustainability of the forests, PEFC certified by the international system , is based on the principles adopted by the UN Conference in Rio de Janeiro in 1992, ie ecological, economic and social;
- Based on the ecological principle the woods, in addition to the production of wood and non-wood products (eg . Mushrooms, fruits and truffles) provides a range of essential services to local communities (protection against erosion , shallow landslides and avalanches, climate local , landscape , recreation) and supra local (protection of the water cycle , global climate , many species of animals and plants);

- That according to the principles of economic and social forest, if properly managed and sustainable , represents an opportunity for the people of the mountains but also for the nation itself;

- That the management of multifunctional, sustainable and certified forest allows you to enhance the recreational aspects without unduly penalizing the other functions of the forest , including the production that is the only function that generates income for the owner;

whereas

- **PEFC Italy** aims to promote sustainable forest management through certification of products made with raw material from forests managed in a responsible manner;

- More than 9% of Italian forests are PEFC certified;

- In Italy more than 800 companies have certified the use of wood and paper products from forests managed in a sustainable manner according to the PEFC system;

- The adoption of procurement policies "green" (as in the European Commission Communication no. 2020 3 March 2010) :

- o allows to reduce the environmental impact ,
- o enhances the performance and quality standards of products and services ,
- o stimulates the processes of eco- innovation in the industrial system , in supply chains
- o enhance the eco- competitiveness of enterprises;

- The Association is committed to communicating to consumers and to the public the importance of value and benefit of forest resources in a responsible and compatible;

- The association is committed to promoting the use of PEFC certified products to support homeowners and businesses that implement sustainable management of local forest resources ;

and that

- **F.I.S.O.** aims to enhance the environmental resources in a responsible manner in which they conduct their activities outdoors , adopting consistent behavior to achieve the objectives of:

- encourage their members to adopt lifestyles environmentally correct, respectful of resources and best practice waste reduction and waste;
- disseminate information through their effective communication tools on environmental concerns;
- develop ethically virtuous to protect the values that are the foundation of our quality of life and that of future generations as land conservation and cultural identity , respect for the individual and civil society;

- In 2014 it is planned to carry out the World Championships in Orienteering in the highland of Asiago and Levico - Lavarone.

PEFC Italy and F.I.S.O. activate agree to a joint communication of environmental activities in the framework of this protocol.

In particular, the collaboration involves:

- A joint declaration on the promotion of sports activities in natural areas and in the woods , their importance , methods of implementation and sustainability;
- Communication of sustainability Orienteering , which is practiced in natural environments of high quality, subject to a multifunctional and sustainable utilization , with particular reference to the Federal Centre for Orienteering Paluzza as " Best Practices " in the field of sports practices sustainable;
- A common commitment to the promotion of knowledge Orienteering , as a sport that takes place in the natural environment , sustainable and which promotes the knowledge, respect and protection of the natural environment and forestry , in particular, will be given information on the characteristics of the areas forest where events are held and their certification;
- The proposal to dedicate , in orienteering training and outreach initiatives , aimed particularly at schools , a space dedicated to in-depth knowledge of sustainable forest management and timber managed by PEFC referents;
- The proposal to encourage, in the demonstrations and orienteering competitions , the use of food and non- locally sourced , in order to intensify the relationship with the land ;
- The implementation of a " green purchasing policy " by the FISO , the Subsidiaries and the Federal Center , with the use of sustainable products and certificates (paper - graphic and tissue - and wood);
- An undertaking to give visibility to the PEFC certification on all paper-based communication , visibility that comes with the PEFC logo on certified paper and attached statements (" promote the sustainable management of forests " , etc.);
- The drafting of joint press releases on the sustainability of the most important national events before, during and after the event;
- Calculation by PEFC CO2 savings due to the use of certified material (paper, wood);
- The organization of a press tour for the communication of the sustainability of the practice of orienteering and the event of the world championships 2014.
